2006 BOYS STATE INAUGURATION



Yesterday afternoon the citizens elected to state positions were inaugurated to their office—a bittersweet event. Immediate past-president Afeef Ahmed (F) delivered his farewell address, highlighting his gratitude towards the Boys' State program, and this year's citizens. He also wished his successor, Uzi Ibrahim, the best of luck in his upcoming term. The keynote speaker was the Honorable Fred L. Fox III, judge of the 16th Judicial Circuit Court. An ex-marine and graduate of WVU Law (as a member of the Order of the Coif), Fox is now a member of the American Legion and the recipient of 2 Bronze Stars, the Purple Heart and the Cross of Gallantry. Fox has sworn in Boys State elected state officials for over a decade, and spreads a message of honor and partisanship; "You are all here because someone has recognized you as a leader—and your chances of leadership later in life are great." After the other elected officials were sworn in, Uzi Ibrahim (N) took office as Governor and delivered his inaugural address. In this address Ibrahim thanked the voters of both political parties, the staff, and the Legionnaires for providing him with a "wonderful opportunity" to serve as head of Boys State.

Education: The keystone to success

As citizen's intently listened to the perplexing debate on Tuesday night, education came to the forefront of both platforms. The future leaders of tomorrow focused on the subject which will catapult them into our capitalist society; the subject which is the catalyst in the progression of young minds; the subject which will directly or indirectly affect generations of individuals throughout the course of time.

From the Promise Scholarship to teacher pay raises to tax benefits, a myriad of education-based topics were proposed but not all of them worked. Various flaws plagued the candidates' platforms proposals.

The education plan made by the Nationalist Party was to increase the educators pay, therefore satisfying the teachers, thus making them teach with more pizzazz and enthusiasm. What they failed to address was where the money for these pay raises would come from. As we scrape to find enough money to support our state as it is, the Nationalist plan is sure to drive our state into increasing debt.

Sure, the teachers do deserve more money, but is that the most important issue in the state? Is the funding for vital character developers such as athletics and academics not more important? At the debate, both parties felt it necessary to extrapolate the promise, but neither had a plan on how to fund this extension, the most important aspect of the whole plan.

Giving the youth of our nation more money for their higher education is a wonderful thought, but how will those youth function as adults when they must live in a society filled with inflation and debt. Since 2003, the legislature has been searching vigorously for a way to fund this great scholarship, but each year requirements for the students must be raised to accommodate the lost funding. What the parties should have focused on was ways to boost the economy in the state, therefore, providing more revenue which in turn can be used to initiate the education proposals. One must admit, however both parties did do one thing right—centering their platforms on the keystone of society, the youth of West Virginia.

MANCHIN SPEAKS AT BOYS STATE LUNCHEON

Yesterday afternoon the Honorable Governor Joe Manchin appeared as the lunchtime speaker. He invoked the spirit of patriotism by quoting past-president Thomas Jefferson; "Whenever the people are well informed they can be trusted to govern themselves." Manchin, previously the Secretary of State, was elected as the 34th Governor of the State of West Virginia and sworn into office on January 15th, 2005. He is a graduate from West Virginia University with a dual major in Business and Economics, and pioneer of the popular programs, "West Virginia SHARES" (Saving History and Reaching Every Student). Its' principles and goals are very similar to those of Boys State, encouraging citizens to learn from the older generations—parents, grandparents, veterans, teachers, etc.—about their civic duty to be patriotic and vote. He reminisced about the past "great generation" (the youth of today's grandparents) who overcame such obstacles as the Great Depression, WWII, and Vietnam, and expressed his wish that the future of America be as headstrong as our predecessors in national and global affairs. Governor Manchin emphasizes the importance of youth in the state's future; "West Virginia is on the verge of greatness because I'm looking at the next great generation. You, the youth, are the next great generation. God bless you all, and God bless America."
