Legislature Travels to Charleston

Select members of ALMBS traveled to Charleston on Thursday and participated in mock government sessions. Members of the Senate and House of Delegates were driven to the State Capital, where they were introduced to West Virginia House leaders that led the sessions. The Senate, headed by Will Collier, passed numerous bills, including a reform on the hotly contested PROMISE Scholarship and the enactment of a statewide 'Pepperoni Roll Day'. Under Speaker of the House Ian Avis, the House passed many bills including prison reforms and concealed carry options.

The Public Works board met with Commissioner of Agriculture Walt Helmick. After a brief lunch break, Governor Niall Diehl delivered his State of the State address to the entire Congress. The Congress met again in the afternoon to advance through more legislation. The experience was beneficial for the young Congressmen, as it exposed them to collaborative work and real-world situations. As summed up by President of the Senate Collier, "We accomplished a lot as a whole. The experience was great."

“More than 11,000 arrested after brutal ways of killings”

Authorities in the country of Bangladesh have arrested over 11,000 citizens after a wave of brutal killings by extremists. Bangladeshi authorities have stated that they have arrested roughly 145 suspected Islamist militants. Police stated that all of the arrested militants were suspected of being in the banned Islamist group, Jama'atul Mujahedin. All of the others were everything from drug dealers to thieves to those accused of violent acts. Bangladesh has recently been subject to a surge of targeted killings blamed on Islamic radicals. They have violently murdered religious minorities, secularists, and gay activists. Also, in a possible act of revenge, an officer's wife was slain.



“Alligator attacks toddler at Disney”

Tuesday night, a 2 year old toddler was taken by an alligator in a lagoon outside of the Grand Floridian Hotel in Disney near Orlando, Florida. This has caused Disney to close all beaches in its resort area “out of an abundance of caution.”

The boy's family was at an outdoor movie night around 9 p.m. at the Grand Floridian Hotel when the boy wandered off. The lagoon is connected to a series of large canals that feed into large bodies of water. The father stated that he attempted to rescue his son by rushing into the water and wrestling the beast, suffering minor scratches as a result. The body of the toddler has since been found.

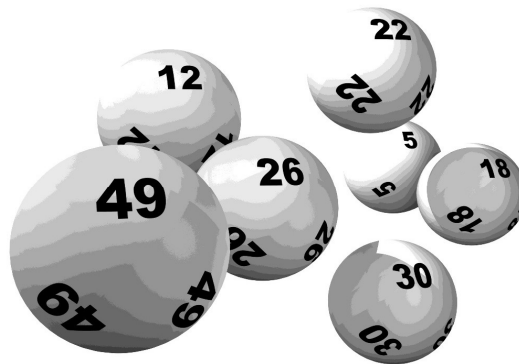

Most of the DMV workers represent themselves as poorly qualified for the job due to their misconduct and immaturity. Yesterday, I went to the DMV to get my license, which was an extremely difficult task to accomplish due to the fact that it was required of me to take the test five times even though I passed the first time. Considering the situation I was trying to decide whether I wanted to sue the DMV or not. At least in the process of all that I was able to get a better look at the DMV facility. The Director of the DMV was not the problem and neither was the rest of the workers, but perhaps the problem was the facility as a whole. I was able to notice that although some of the workers were very helpful, those who weren't were in fact extremely difficult and did not know how to handle any situation properly.

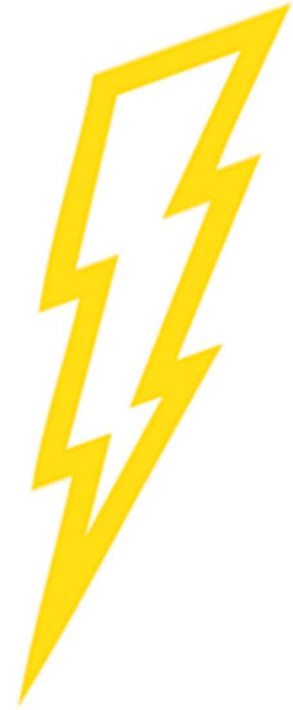

“EgyptAir Black Box Found”

The cockpit voice recorder, also known as a “black box”, of the missing EgyptAir flight 804 was found in the Mediterranean Sea on Thursday. The black box, one of two on the vessel, is slightly damaged but believed to be operational. If functional, the black box should contain the last 30 minutes of the flight. The process to recover the data should take around 48 hours to complete. The black box is currently being transported to the city of Alexandria, Egypt. Once there, it will be given to the overseers of the search committee who will analyze the data.

“Darren Sharper Sentencing Delayed”

The sentencing date for ex-NFL star Darren Sharper has been delayed until late August. Sharper's sentencing date had originally been set for this week in New Orleans. This time change allows prosecutors to better evaluate Sharper's drug and sexual assault case. Sharper has already pleaded guilty or no-contest to related charges in Arizona, Nevada, and California.

Organized Chaos

The Citizens of Boys State have been having difficulty following directions because of the way those directions have been given to them. The Journalism staff have gotten several complaints about the navigational instructions and have been asked to write about it as it has become one of the main issues around the community. I have witnessed officer's abuse their power on people that are trying to follow the rules while the trouble makers have been given favor. To even walk on the sidewalks here in our role play state you must test to get a "Walking License" to avoid getting further harassed by the State Police. This is obtained by making a visit to the Department of Motor Vehicles. This introduces a whole new type of harassment. While I got my license perfectly fine I have heard stories and even witnessed several issues at the DMV. The one I witnessed was someone taking the test multiple times even though his answers were correct. So, we went to go do something about it, visiting the state police seeking help. We found none.

Due to misinformation and an unorganized format my experience here at Boys State has been filled with questions with little to no answers. This isn't just me. There is a surprising majority of citizens and counselors that mirror my feelings about the incompetence in which things are run. The more I wanted to get involved in Boys State activities, the more I ran into questions without answers, experiencing oppression from people that quite simply don't care about you or your experience. I had high expectations for this camp and am going to leave it disappointed. While I Hope that people had a better time than I have, I just wanted to let citizens that feel the same way know that they are not alone, with that being said maybe some staff will read my concerns about how some things are ran that way the future of Boy's State can be great for all citizens not just a select few.

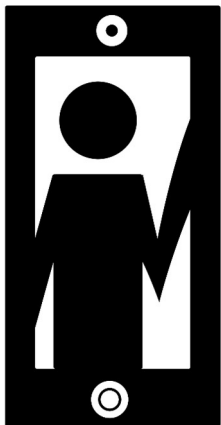
Day is done, gone the sun
