# Nation Capitol Police Prevented Massacre in Virginia

This is a breaking news story and is submit to change as updates arise. At an early morning baseball practice in Alexandria, Virginia at least four Republican congressmen were wounded when a gunman began shooting at random. House Majority Whip, Steve Scalise, was among the men injured; he was shot in the hip and was transported to MedStar Hospital Center in Washington, D.C., where he is currently in stable condition and undergoing surgery. Alexandria Police Chief Michael Brown said five people were taken to local hospitals, including the suspect (whose identity is still unknown) following the shooting.

President Trump also released a statement after being briefed on the story.

"The Vice President and I are aware of the shooting incident in Virginia and are monitoring developments closely," he said. "We are deeply saddened by this tragedy. Our thoughts and prayers are with the members of Congress, their staff, Capitol Police, first responders, and all others affected."

Both Democratic and GOP baseball teams were practicing earlier that morning. However, no shots were fired until the Republican Party began their practice. Senator Rand Paul was at the batting cages when this occurred, and he described it as the following: "There was a rapid succession of shots, you know five or ten shots. In the field, I see Representative Scalise is shot but moving, and he's trying to drag himself through the dirt and out into the outfield." The Capitol Police finally arrived after a reported 50-60 shots were fired, taking swift action to detain the shooter before anyone else was injured. About a block away from the baseball field, children were walking to school.
