ELECTION EXCITEMENT MOUNTING

STATE SUPERINTENDENT KEYNOTES BOYS' STATE

State Superintendent of Schools Daniel B. Taylor keynoted the 35th annual Mountaineer Boys State Sunday night at the first assembly of the 371 boys gathered here from throughout West Virginia.

Echoing and expanding on the Boys' State purpose, stated by Boys' State Administrator Tommy E. Jones as being

to "teach good government through participation," Dr. Taylor pointed out that "Boys' Staters have the opportunity not just to learn but also to live participation in good citizenship."

Coming from different localities and with varying racial, religious and cultural back-rounds, Boys' Staters, said the educator, are learning here to live together. We have to learn to live together. This is our preatest need today."

"If there is any message that the young generation has for the older generation, it is that this is possible. You will find in the process, however, that it isn't always easy."

Looking beyond this week, Dr. Taylor asserted that the real purpose of Boys' State "is not just to get you to noon Saturday, but to get you from Saturday to wherever it is that you want to go. There will be many pitfalls along the way."

One, he said, is the temptation to apply imple solutions to very complex problems.

"Labeling," he warned, "is much easier than hinking, which involves giving consideration thoughts different from our own-weighing and assessing those thoughts, and reconsidering our own position."

An open mind, he cautioned, is not the same is "willy-nilly" following any suggestion by omeone else and lacking the courage of one's win convictions.

E. Hans McCourt is advisor to the Federalists, assisted by Elwood McPeak and Augustine Mazzei.

Filing 8 a.m. - 2 p.m.

Filing for state offices at GHQ (Harrison County) will begin at 8 a.m. today, when Thad Pritt, acting secretary of state, will begin accepting filing fees from candidates for state offices. County office filings should be made with county counselors, starting at 8 a.m. The filing period will end at 2 p.m.

Voting will take place immediately after tonight's assembly and continue until 10 p.m when the polls will be closed.

All Boys' Staters must take the bar examination at 1:15 p.m. today in the Assembly Hall. Passing the examination is a requirement for lawyers and therefore for prosecuting attorneys, judges and justices of the peace candidates.

Ballots will be distributed today after results of the bar examination are known. State office ballots are prepared at headquarters; county ballots are prepared by election officials in each county.

RULES ON POSTING

Candidates were advised in the Sunday night assembly that there are rules concerning posting of election materials: no thumb tacks or nails are allowed; no material is to be placed inside the dining room; no material is to be higher than a citizen can reach, an each candidate is responsible for removing his campaign material after the election.

AMERICAN LEGION MOUNTAINEER BOYS' STATE ATHLETIC PROGRAM - GENERAL RULES

It will be the responsibility of the athletic representatives of each county to insure that teams are fielded in accordance with the schedule. It is of the utmost importance that the teams report to the correct area at the prescribed time. In the event a scheduled game is not played, the Athletic Director will deter-mine if the game shall be classified as a cancellation or a forfeiture on the part of one team. The final team standing will be determined on a point system, all scheduled games being of equal value, regardless of sport. It will be necessary for the counselors to serve as referees and umpires where needed.
