He touched down in the State helicopter in front of the Assembly Hall at 2:30 P.M. After greeting staff members and elected officials of Mountaineer Boys' State at GHQ, he proceeded to the reviewing stand for the formal review by the Boys' Staters, which he rated among the hest he had observed during his visits to Boys' State. He addressed the citizens in the Assembly Hall and then devoted several hours to answering questions submitted to him by the citizens with no holds barred.
