THE HONORABLE RICHARD NEELY, JUSTICE OF THE WEST VIRGINIA SUPREME COURT OF APPEALS ADDRESSED THE CITIZENS IMMEDIATELY FOLLOWING THE EVENING MEAL LAST NIGHT. (BIOGRAPHY ATTACHED)

THE HONORABLE ARCH A. MOORE, JR., FORMER GOVERNOR OF THE STATE OF WEST VIRGINIA AND REPUBLICAN CANDIDATE FOR UNITED STATES SENATOR WAS THE GUEST SPEAKER AT THE ASSEMBLY LAST EVENING. FORMER GOVERNOR MOORE HAS BEEN A GUEST SPEAKER MANY TIMES AT BOYS' STATE AND IS A LONG TIME FRIEND AND SUPPORTER OF THE AMERICAN LEGION MOUNTAINEER BOYS' STATE PROGRAM. HE CONCLUDED HIS REMARKS WITH HIS USUAL QUESTION AND ANSWER SESSION IN WHICH THE CITIZENS OF BOYS' STATE ACTIVELY PARTICIPATED. FOLLOWING HIS ADDRESS THE POLITICAL RALLIES OF THE FEDERALIST AND NATIONALIST PARTIES WERE HELD PRIOR TO THE CITIZENS GOING TO THE POLLS.

IMMEDIATELY FOLLOWING THE ELECTION LAST NIGHT, RECOUNTS WERE CALLED FOR IN THE GUBERNATORIAL RACE, ATTORNEY GENERAL AND COMMISSIONER OF AGRICULTURE. AFTER RETABULATIONS, THERE WERE NO CHANGES IN THE WINNERS AS ANNOUNCED

Michaeld Neely Justice

RICHARD NEELY, born August 2, 1941, the son of John C. and Elinore Neely of Marion County, West Virginia; grandson of West Virginia's twenty-first governor. Educated at Dartmouth College, A.B. in Economics, and the Yale Law School, L.L.B. 1967. Served as Captain, United States Army Artillery; awarded Bronze Star from the Vietnam conflict. Elected to the West Virginia Legislature from Marion County 1970; elected West Virginia Supreme Court of Appeals 1972.
