WEST VIRGINIA DAY!

THE HONORABLE JOHN D. ROCKEFELLER, IV, GOVERNOR OF THE STATE OF WEST VIRGINIA, visited Boys' State yesterday afternoon. He arrived by helicopter and after greeting Boys' State officials at Harrison Cottage, he proceeded to the reviewing stand for the formal review by the citizens of Mountaineer Boys' State. He addressed the citizens in the Assembly Hall and then devoted time to answering questions submitted to him by the citizens. Governor Rockefeller invited Governor Zachwieja to accompany him on a white water raft trip down New River Gorge next week.

Commander George Zanos presented Governor Rockefeller with a belated birthday cake and the citizens of Boys' State sang Happy Birthday. Governor Rockefeller celebrated his 43rd birthday yesterday.

Speaker for the Thursday evening assembly was THE HONORABLE ROBERT EARL MAXWELL, JUDGE OF THE UNITED STATES DISTRICT COURT FOR THE NORTHERN DISTRICT OF WEST VIRGINIA. Judge Maxwell has been a long time supporter of Mountaineer Boys' State and is an honorary Boys' Stater. (See biographical attached)

THE HONORABLE GLEN GAINER, STATE AUDITOR brought greetings to all Boys' Staters yesterday following the noon-day meal. (See biographical attached)

The Boys' State Legislature convened Wednesday morning and elected PHIL SCOTT - Calhoun (Spencer), PRESIDENT OF THE SENATE and ROBERT E. ZUTAUT - PANHANDLE (Crab Orchard) as SPEAKER OF THE HOUSE OF DELEGATES.

JOHN D. ROCKEFELLER IV (Democrat), of Charleston, born in New York City, June 18, 1937, son of Mr. and Mrs. John D. Rockefeller 3rd; graduate of Phillips Exeter Academy and Harvard University, with additional studies at International Christian University in Tokyo, Japan, and Yale University; honorary degrees from West Virginia University; Marshall University, University of Cincinnati, University of Alabama, Davis and Elkins College, Salern College, West Virginia Institute of Technology, Dickinson College, Bethany College and West Liberty College.

Married to the former Sharon Percy on April 1, 1967; three children, John (Jamie), Valerie and Charles.

Appointed in 1961 by President John F. Kennedy to the National Advisory Council of the Peace Corps; appointed special assistant to Peace Corps Director R. Sargent Shriver in 1962; served in the U.S. Department in the Bureau of Far Eastern Affairs as desk officer for Indonesian Affairs and as special assistant; appointed by Attorney General Robert F. Kennedy in July, 1964, to work in West Virginia with President's Commission on Juvenile Delinquency and Youth Crime; social worker in Emmons, West Virginia.

Elected in 1966 to the West Virginia House of Delegates; elected West Virginia Secretary of State in 1968; Democratic nominee for Governor in 1972; chosen as twelfth president of West Virginia Wesleyan College in Buckhannon in 1973; resigned and announced for Governor in 1975; elected Governor in November, 1976 by largest victory margin in state's history.

Became first West Virginian in 1969 to be chosen by U. S. Jaycees as one of the "Ten Outstanding Young Men in America"; was one of twelve college and university presidents chosen in 1974 to represent the United States in a month-long visit to the People's Republic of China; included in Time magazine's list of "a new generation of leaders" for the country's bicentennial era; serves as trustee of University of Notre Dame and University of Chicago; former board member of the Rockefeller Foundation; member of Visiting Committee on East Asian Studies at Harvard University; member of Executive Committee of National Governors' Association; chairman of Subcommittee on Coal of the National Governors' Association; member, U. S. Department of Interior task force on surface mining; member, National Council on Health Planning and Development; member, Charleston Rotary; member, First Presbyterian Church of Charleston.



ROBERT EARL MAXWELL, (D), of Elkins, was born on March 15, 1924, the son of Earl L. Maxwell and Nellie E. Maxwell; educated in Randolph County Schools and Davis and Elkins College; LL.B. College of Law, West Virginia University in 1946; married Ann Marie Grabowski in March, 1948; four children, Mary Ann, Carol Lynn, Ellen Lindsay and Earl Wilson; commenced private practice of law in Randolph County, June 1, 1948; member of Randolph County Bar Association, The West Virginia State Bar, the West Virginia Bar Association, American Bar Association and American Judicature Society; Catholic; elected Prosecuting Attorney of Randolph County in 1952, reelected 1956 and 1960; appointed United States Attorney for the Northern District of West Virginia by President Kennedy on March 15, 1961, resigned January 31, 1964 to return to private practice; elected Delegate to Democratic National Conventions in 1956 and 1964; appointed by President Johnson on July 19, 1965, as Judge of the United States District Court for the Northern District of West Virginia; Chairman Budget Committee of the Judicial Conference of the United States, Member, Committee of the Federal Judicial Center supervising the preparation of Federal Judicial Bench Book; Faculty Member, Federal Judicial Center; Former President, District Judges' Association, Fourth Circuit; 1969 recipient Alumni Distinguished Service Award from Davis and Elkins College.



GLEN B. GAINER, JR., (D), of Wood County, born in Parkersburg, July 4, 1927, son of Glen B. Gainer, Sr. and the late Nettie E. Gainer; educated in the public schools of Wood County and graduated from Parkersburg High School in 1945; attended Glenville State College and graduate of Marietta College, Marietta, Ohio, A.B. degree; completed post graduate work from West Virginia University; married to the former Sally Jo Padgett, October 31, 1955; two children, Beth Lyn and Glen B. Gainer, III; served in the United States Navy; high school government teacher and former coach; elected Mayor of the City of Parkersburg, served from 1969 to 1971; listed in International Who's Who and member of several civic and fraternal organizations; elected State Auditor on November 2, 1976 and assumed the duties of State Auditor on January 17, 1977.
