# LATE GOVERNOR HONORED

We are dedicating this "Forty-Eighth Annual American Legion Boys' State" Program to Van Jetson Daniels of McDowell County in West Virginia. Van was a very kind and unassuming young man who reached for the best there was, and worked to get it. In 1970 he became the first black candidate to be elected Governor of Boys' State. He made a good and effective Chief Executive, became a leader in his community, and went on to graduate from college and receive his medical degree. A year or more ago, the young physician was interviewed by a Charleston newspaper, steems from the fact that the Daniels family, a very modest mining family from a little McDowell County coal camp, had several children who were doctors and nurses ... all of whom had worked their way up by way of physical labor.

Moreover, in the interview, Van voluntarily bestowed almost all the credit for his success in the exceedingly difficult and trying profession of medicine on his experience at Mountaineer Boys' State... and especially to the late L. D. Smith of Huntington, who took it upon himself to guide the young man over the proper pathways of life, and to encourage him when discouragement was so abundant. The coming McDowell doctor implied that he cound never have made it without what he had learned and the people whom he had met while a citizen of Boys' State, especially L. D. Smith.

We had planned to invite Van to come up to Jackson's Mill this year to meet and talk with the young men here. However, the fates were not co-operative. Several months ago young Dr. Daniels was killed in a car wreck... a terribly unkind destiny which snuffed out a life which was committed to serving those who needed it most; and robbed the American Legion Boys' State Program of one of its most loyal boosters as suddenly as a rock dropping from the heavens.

It is to his memory that we dedicate this program.
