Citizens of Boy's State vs. Administration of Boy's State

Decision entered June 19, 1986.

Scott Estep representing the citizens of Boy's State as brought before the Supreme Court of Appeals of WV on the 19th day of June, 1986, the Boy's State Attorney General, representing the citizens of Boy's State has requested a writ of mandamus to compel the administration of Mountaineer Boy's State to uphold and enforce the decision of the 1984 Boy's State Supreme Court which voided the 18th Amendment and adopted a new law. This law stated the program for evaluation of lawyers in WV Mountaineer Boy's State was unconstitutional. The new law stated that the administration should only allow the scorers in the top 37.5 percent of the Mountaineer Boy's State Bar Exam be deemed fit to become lawyers, provided that everyone took the bar exam. Stated another way, the top 37.5 percent of the scores will be deemed passing grades, and will provide eligibility for the Boy's State Bar Assoc.

The writ is issued to force the administration to void the 18th amendment and adopt the new standards made in 1984 which were not followed by the administration. The court further orders that all the opinions written by the Supreme Court and the law conceived there in shall be published in the Boy's State Manual in the future. Also, the court specifically orders that this decision and the 1984 decision be published in the camp newspaper and future manuals. The court finally advises all citizens and others associated with Mountaineer Boy's State that the decisions of the Supreme Court are binding law until overruled by the Supreme Court or validly ratified constitutional amendment.

CITIZENS OF BOYS' STATE vs. BOYS' STATE LEGISLATURE

Decision entered June 21, 1984

As brought before the Supreme Court of Appeals of West Virginia on the 21st day of June, nineteen hundred and eighty four, the Boys' State Attorney General, representing the Citizens of Boys' State, has questioned the constitutionality of the eighteenth amendment to the Boys' State Constitution ratified by a special election, June 18, 1982 by the 1982 Boys' State Legislature.

The eighteenth amendment states that the Bar Exam "will be based on a percentage grade whereby each person that passes said percentage will have passed the examination. Said percentage shall be 60% and shall not fluctuate. Each question shall be worth one point whether right or wrong." We today consider whether this enactment of the Legislature passes constitutional muster.

According to the Separation of Powers Doctrine, the power to determine the eligibility of a lawyer to act before a court of law is vested exclusively in the Supreme Court of Appeals of West Virginia.

Thus, the amendment governing the Bar Exam has been ruled unconstitutional and void from the Mountaineer Boys' State Constitution by means of improper statutory procedures and in violation of the Separation of Powers Doctrine.

With the repeal of the amendment, the court must now face the task of establishing a standard for future admittance to the Mountaineer State Bar.

The Separation of Powers Doctrine vests specific powers in the executive, legislative, and judicial branches of the government. As the Supreme Court has exclusive power to rule on lawyer acceptance, as stated in the Separation of Powers Doctrine, it has been decided that the most effective program to prepare for evaluation of lawyers which will be before a West Virginia Court of Law is through standards by which the before mentioned exam allows for only the top scores of the 37.5% of the Citizens of Mounaineer Boys' State be deemed to pass the Bar provided that everyone take the Bar exam. Stated another way, the top 37.5% of the scores will be deemed passing grades, and will provide eligibility for the Boys' State Bar Association.
