


DR. JOHN DOMBROSKY:

EVENING SPEAKERS FOR MONDAY, JUNE 13, 1988:

The Monday evening speakers were Charlotte Lane, a Supreme Court Justice candidate, and John McCuskey, Commissioner of Finance and Administration.

Mrs. Lane congratulated the Citizens on being selected to participate in Boys' State. She commented that she had been elected to the Girls' State Supreme Court and hoped that her dream would come true this fall.

The candidate for Supreme Court Justice outlined three

guidelines for the Citizens:

1. Be Positive and strike the word "can't" from your vocabulary. Regardless of your shortcomings and setbacks, always be optimistic and upbeat, focusing on what is good and looking for opportunity.

2. Have faith in West Virginia - It's a great state with many advantages. We are going through a revitalization

process to make our economy strong again.

3. Maintain a sense of humor. Always take your job and responsibilities seriously, but not yourself.

Mrs. Lane lives by this advice and it has served her well

through her terms with the House of Delegates, Public Service
Commission, and now, as she runs for statewide office.

She also added, "It's important to be kind to your adversaries and remember the saying, 'What goes around, comes around,'
She continued, "An opponent today may be a valued ally at some time in the future. Being courteous, kind and unassuming is a better testimony of yourself than arrogance and nompousness." better testimony of yourself than arrogance and pompousness."

Mr. McCuskey spoke of the time when he was a shy Boys' State Citizen who didn't run for an elected office; although he d

receive an award for his good citizenship.

The Commissioner of Finance and Administration emphasized the importance of citizenship and how good citizens are the checks and balances on our public office holders. We elect them and our vote can also defeat them.

Mr. McCuskey also stressed the importance and value of getti involved with the proceedings of the week. The friendships you make this week will last many years and provide you with contacts in all parts of the state.

In keeping with his tradition, Mr. McCuskey limited his remarks and kept his talk short, much to the delight of the audience on a hot and humid June evening.

SECRETARY OF STATE SPEAKS AT NOON MEAL:

Secretary of State, Ken Hechler, addressed the Citizens with an upbeat talk at the noon meal on Monday, June 14, 1988. Mr. Hechler's talk centered around the theme of "getting involved", the theme of your week here at Boys' State. The Secretary of State spoke on "Ethics Legislation" and

The Secretary of State spoke on "Ethics Legislation" and bringing West Virginia in line with 34 other states that have passed similar laws. "It's a shame we haven't been able to get this bill through the Legislature. This past session the bill cleared the House of Delegates, but was killed in the State Senate," said Hechler.

He encouraged the Citizens to "Lobby" their elected officials when they return home to their communities. Mr. Hechler said, "We should 'level the playing field' by having Congress and the State Legislature pass campaign spending limitations. Such a law would make it easier for Boys' State Citizens, their counterparts from Rhododendron Girls' State, and all West Virginians to run for public offic in a fair and equitable manner."

Mr. Hechler concluded his message by relaying a story about a banker friend of his from Keystone in McDowell County. The gentleman, upon graduating from college and returning home, was told by his father to go out on the front porch to receive a gift. The son was expecting a beautifully wrapped present. The father turned his son around a full 360 degrees so that he could view everything around him. The father then told his son, "My gift to you is the world. Go out and conquer it." Mr. Hechler said his gift to Boys'State is West Virginia, "Go out and build it and make our state a better place."

Once again, we are very grateful to Mr. Hechler for taking time from his responsibilities and heavy schedule to participate in Boys' State. He is always welcome here at Jackson's Mill.
