#### GOVERNOR ARCH A. MOORE, JR.

Governor Moore was on hand for the Formal Review of the American Legion Mountaineer Boys' State at Jackson's Mill today.

He began his political career at the age of 23 as a State Legislator. He then was a member of the U. S. Congress, after which he became the Governor of West Virginia and served two consecutive terms. The 8 years following his terms as Governor, he practiced law in the City of Charleston and Glendale, West Virginia.

In 1984, he was again elected as Governor of WV. He is now seeking re-election for another term as Governor.

After formal review, the Citi zens gathered at the assembly hall for a session with Governor Moore. He spoke to the Citizens about leadership. He was very complimentary to the Cizitens upon being chosen as Boys' State Citizens from their high schools.

The last hour of the session was spent in question answer form.

Governor Moore was well received by the Citizens. We always welcome him here at Jackson's Mill and wish him luck in his campaign.



ROBERT EARL MAXWELL (D) of Elkins, was born on March 15, 1924, the son of Earl L. Maxwell and Nellie E. Maxwell: educated in Randolph County Schools and Davis and Elkins College; LL B. College of Law. West Virginia University in 1949; married Ann Marie Grabowski in March, 1948; four children. Mary Ann, Carol Lynn, Ellen Lindsay and Earl Wilson; commenced private practice of law in Randolph County, June 1, 1949, member of Randolph County Bar Association; The West Virginia State Bar, the West Virginia Bar Association, American Bar Association and American Judicature Society; Catholic; elected Prosecuting Attorney of Randolph County in 1952, reelected 1956 and 1960; appointed United States Attorney for the Northern District of West Virginia by President Kennedy on March 15, 1961, resigned January 31, 1964 to return to private practice; elected Delegate to Democratic National Conventions in 1956 and 1964; appointed by President Johnson on July 19, 1965, as Judge of the United States District Court for the Northern District of West Virginia, Past Member, Budget Committee of the Judicial Conference of the United States: Former President, District Judges' Association, Fourth Circuit: 1969 recipient Alumni Distinguished Service Award from Davis and Elkins College; Appointed 1980 Judge, temporary Emergency Court of Appeals.

## COLONEL DONOHOE SPEAKS TO CITIZENS:

Colonel Fred Donohoe, Superintendent of the West Virginia Department of Public Safety, spoke to the Citizens at the noon meal on Thursday, June 16, 1988.

He spoke to the Citizens about the fact that training and education are expensive, but ignorance is more expensive.

Only 17% of the State Trooper's time is spent on road patrol. 83% is spent on preventing and investigating crimes.

We have a crime rate in the State of 21 per 1000, and the National average is 55 per 1000. For the last 14 years, West Virginia has had the lowest national rate for crimes. West Virginia also has enjoyed the highest conviction rate for major crimes.

We appreciate your visits with us, Col. Donohoe. We wish you much success as you continue to administer to West Virginians through your Department of Public Safety.



COLONEL WILLIAM FRED DONOHOE, of Barboursville, born December 17, 1932 at Spencer; education, public schools and Balboa Junior College and Glenville State College; served three and one-half years in U.S. Air Force; enlisted in State Police on June 14, 1954; graduated from State Police Academy and was assigned to Morgantown Detachment; transferred to South Charleston, 1958; promoted to Corporal and assumed command of Madison Detachment, 1959; transferred to Chelyan as Detachment Commander, 1965; promoted to Sergeant and transferred to South Charleston as Commander of First District, 1966; transferred to Huntington as Second District Commander, 1967; promoted to First Sergeant, Company "B", 1972; rank title changed to Master Sergeant and assumed command of Governor's Security Detail, 1973; promoted to Lieutenant, 1975; transferred to Department Headquarters as Officer in Charge of Traffic Research and Safety Division, 1977; transferred to Department Headquarters and promoted to Captain; served as Chief of Staff at the ranks of Captain, Major and Lieutenant Colonel 1977-85; married to former Delores Hersman: three children—Debra Dean, W. F. Donohoe II and Michael Bruce; member International Association of Chiefs of Police, West Virginia Chiefs of Police, Masonic Lodge in Morgantown, Beni Kedem Shrine Temple, Charleston; appointed Superintendent of Department of Public Safety on February 18, 1985.

## JUSTICE THOMAS MILLER AT JACKSON'S MILL:

Justice Thomas Miller of the West Virginia Supreme Court of Appeals took time from his busy campaign schedule to visit with the Citizens at Mountaineer Boys' State today prior to the evening meal. He is presently a candidate for re-election to the position he now holds. We wish you luck, Justice Miller, and we appreciate your time spent with us here today.

THOMAS B. MILLER was elected to a twelve-year term on the West Virginia Supreme Court of Appeals and took office on January 1, 1977. In 1982 and 1985-86, he served as Chief Justice of the court. In 1979, the West Virginia Supreme Court of Appeals was designated as the Outstanding Appellate Court in America by the American Trial Lawyers Association. In 1980, he received a Certificate of Merit from the National Juvenile Law Center, Inc., for work in the field of juvenile law. Prior to his election to the Supreme Court. Justice Miller was a partner in the law firm of Schrader. Miller. Stamp & Recht in Wheeling, where he practiced law for twenty years. As a practicing attorney, he specialized in trial work. He served as a member of the Unlawful Practice Committee of the West Virginia State Bar and also served as a member of the West Virginia Board of Law Examiners. He graduated from West Virginia University College of Law in 1956 and was a member of the West Virginia in 1950 and was a member of the NROTC at the university. Upon graduation, he received his commission as an ensign in the United States Navy and was assigned to the U.S.S. Levte Gulf, an aircraft carrier, which served in the Seventh Fleet off Korea during the Korean War. He was honorably discharged as a Lieutenant (JG) in 1953. He is married to the former Vaughn Nolte of Wheeling and they have four children.
