




start the process of molding your dreams into realities.

Born November 14, 1936, in Cedar Grove, West Virginia, son of Roger and Pauline Woodrum Tompkins; married to Patty Vandergrift; two children: Benjamin and Adrianna; Episcopalian; graduated from West Virginia University in 1958; received Rhodes Scholarship and earned BA and MA in philosophy and economics from Oxford University; graduated from Yale Law School in 1964 where he served as Managing Editor of Yale Law Journal; joined Charleston law firm of Bowles, Rice, McDavid, Graff and Love in 1971; served as Counsel to Senate Committees on Mines and Mining, Health, and Military Affairs during 1973 legislative session; elected to House of Delegates in 1974; served as Chairman of the Judiciary Committee, 1977-78, and as Majority Leader, 1979-82; practiced private law from 1982 until September, 1989; appointed Attorney General by Governor Caperton and took office September 5, 1989.

U.S. Army 1958-61, Infantry and Adjutant General Corps. Received law degree from West Virginia University College of Law, 1964; member of the Order of Coif legal honorary. In law school he was Associate Editor of the West Virginia Law Review. He served as law clerk to Judge Harlan Calhoun, West Virginia Supreme Court of Appeals, 1966-68. President, West Virginia Judicial Association, 1981-82. He was elected Judge of the Circuit Court of Kanawha County in 1974 and re-elected in 1976; chosen by other judges in Circuit Court to serve as chief judge, 1974-80.

He and his wife, Judith, have four children: Karen, Cindy, James, and John. We appreciate the time he has taken from a busy schedule to be with us at Jackson's Mill for the 53rd American Legion Boys

State.
