JUDGE MAXWELL SPEAKS TO CITIZENS

Judge Robert Maxwell is presently a Judge of the U.S. District Courts for the Northern District. Judge Maxwell spoke to the citizens and gave an inspiring message. Thank you for your contribution to Boys' State, Judge Maxwell.

ROBERT EARL MAXWELL (D) of Elkins, was born on March 15, 1924, the son of Earl L. Maxwell and Nellie E. Maxwell; educated in Randolph County Schools and Davis and Elkins College, LLB College of Law, West Virginia University in 1949; married Ann Marie Grabowski in March, 1948; four children, Mary Ann, Carol Lynn, Ellen Lindsay and Earl Wilson; commenced private practice of law in Randolph County, June 1, 1949; member of Randolph County Bar Association, the West Virginia State Bar, the West Virginia Bar Association, American Bar Association and American Judicature Society; Catholic; elected Prosecuting Attorney of Randolph County in 1952, received 1956 and 1966; appointed United States Attorney for the Northern District of West Virginia by President Kennedy on March 15, 1961, resigned January 31, 1964, to return to private practice; elected Delegate to Democratic National Conventions in 1956 and 1964; appointed by President Johnson on July 19, 1965, as Judge of the United States District Court for the Northern District of West Virginia, Past Member, Budget Committee of the Judicial Conference of the United States; Fromer President, District Judges' Association, Fourth Creati; 1969 recipient of Ontstanding Community Leadership award of Religious Heritage of America, 1989 recipient of Ontstanding Community Leadership award of Religious Heritage of America, 1989 recipient of Ontstanding Community Leadership award of Religious Heritage of America, 1989 recipient of Onter of Vandolin Award, West Virginia University, 1991 recipient of Merit Award, Davis and Elkins College Beta Alpha Beta; Appointed 1980 Judge, temporaty Emergency Court of Appeals.



STATE TREASURER ADDRESSES CITIZENS

Larrie Bailey served as West Virginia State Treasurer from January 1977 to January 1985. After a six year absence from the State Treasurer's Office, Treasurer Bailey was again elected to the office by more votes than any other opposed candidate in the November, 1990 election.

He is married to the former Joyce Kennedy. They have three children; John, a graduate of Yale University and a student at the College of Law at West Virginia University; David, a student at George Washington University; and Anne, a student at West Virginia University.


Treasurer Bailey holds a BA degree from the University of South Carolina and an MA in political science from West Virginia University. He is the former president of Allegheny Financial Programs, Inc. His Broker/Dealer firm was licensed by the National Association of Security Dealers. Treasurer Bailey was formerly licensed by the Securities and Exchange Commission as a Registered Investment Advisor and has taught classes in Investments at Fairmont State College. Treasurer Bailey is a former President of the National Association of State Treasurers and is now serving as Vice President of the Northeast Treasurer's Conference.

Treasurer Bailey was elected to the West Virginia House of Delegates in 1960. In 1965 he was the Democratic nominee for United States Congressman from West Virginia's First District.

Before beginning his lifelong career in public service, he served three years on active duty in the United States Navy and is now retired with the rank of Lieutenant Commander. Treasurer Bailey served as national Vice-President of the Navy of the Reserve Officers' Association of the United States (1967-1968) and earned the Armed Forces Reserve Medal and the West Virginia Meritorious Service Medal for his service with the West Virginia National Guard.






A LITTLE MIXED UP






THE OLD GREY MARE IS JUST WHAT SHE USED TO BE
